Learn about the AICPA code of Professional Conduct and rules governing independence, integrity and objectivity; the number of different rules Texas CPAs must follow; the importance and relevance of an effective code of conduct; the basis for moral reasoning; what a CPA's primary responsibilities are; the meaning behind "fiduciary relationship" and "stakeholder"; the accountant's priority of duty and loyalty; the ethical responsibility of an accountant; the Texas ethics requirements for mandatory CPE requirement; and what ethics are and why the accounting profession needs ethics.

He currently is serving as a member of the Special Review Committee of the GFOA, on the Education committee for the Auditing section of the AAA, and the Professional Standards Committee for the TSCPA.
